## About the Program/Section

The Counselling and Relationship Services (CaRS) unit aims to ensure the wellbeing of individuals, couples and families by minimising the emotional, social and economic costs of disruption to daily functioning and/or relationships. Services are for all community members including however not limited to, First Nations Peoples, people from Culturally and Linguistically Diverse Backgrounds (CALD), low-income earners, sole parents and those living in rural and remote areas. The Men and Family Relationship Program is positioned within the CaRS unit.

The Men and Family Relationship Program (MFRP) provides information and referral pathways, counselling and support, education and skill training, and community development, to assist men to resolve relationship issues that arise at various stages of their life journey.

Changing funding body priorities, seasonal conditions issues (e.g. drought), and emergency management recovery (e.g. bushfire, flood), can result in the requirement to focus and establish service delivery activity in rural and remote locations.

## Position Summary

The role of Family Counsellor in the Men and Family Relationship Program is to promote the independence and healthy development of individual men and their families through the provision of quality counselling and service delivery through prevention and early intervention strategies both individually and in group settings.
